

# Buckley Insurance Brokers "Plug'n SAVE Gas Card" Contest

## CONTEST RULES & REGULATIONS

### 1. CONTEST PERIOD

The "Plug'n SAVE Gas Card" Contest is presented by Buckley Insurance Brokers Ltd. All references to times are in Eastern Standard Time Zone. The Contest will commence on **July 31, 2015 at 9:00 am and will end on August 30, 2015 at 11:59 pm** (the "Contest Period").

### 2. ELIGIBILITY

2.1 The Contest is open to all legal residents of Ontario who:

- (a) are the age of majority or older at the time of entry into the contest;

All qualifying entries shall be those received online **by 11:59pmEST on August 30, 2015**.

3.2 There is a limit of one ballot per contestant throughout the Contest Period.
